<p><u>AVAILABILITY</u> Available to all consumers of the Association whose load requirements meet or exceed 25 kVA.</p> <p><u>MONTHLY RATE</u> Facility Charge per month kWh Charges per month per kWh Member Demand Charge per month per kVA</p> <p><u>DETERMINATION OF BILLING DEMAND</u> The billing demand will be the maximum 15 minute integrated kVA demand established by the consumer during the billing period as indicated or recorded by a demand meter.</p> <p><u>MINIMUM MONTHLY BILLING CHARGE</u> The minimum monthly billing charge will be the greatest of the following charges as determined for the consumer in question:</p> <ol style="list-style-type: none"> 1. The minimum charge specified in the contract for service; 2. A charge of \$1.50 per kVA of installed transformer capacity. 3. A charge of \$75.00. <p><u>TYPE OF SERVICE</u> Single-phase and three-phase, 60 hertz, at available voltages.</p> <p><u>CONDITIONS OF SERVICE</u></p> <ol style="list-style-type: none"> a. The rated capacity of single phase motors will not be in excess of ten horsepower (10 HP) unless written approval is received from the Association. b. All wiring, pole lines, and other electrical equipment beyond the metering point will be considered the distribution system of the consumer and will be furnished and maintained by the consumer. c.
